A final rule titled "Refinement of Income and Rent Determination Requirements in Public and Assisted Housing Programs: Implementation of the Enterprise Income Verification System – Withdrawal of Rescinded Regulatory Amendments, was published in the Federal Register on January 27, 2010.

The purpose of this final rule is only to revert the regulations found in the January 27, 2009, final rule back to their pre-January 27, 2009, content. This rule DOES NOT affect the regulation changes found in the Final Rule published in the Federal Register on December 29, 2009.
